OFFICE ORDER NO. 146 OF 2024

Reference is invited towards para (d) and (e) of the Headquarters' Office Order No. 35 of 2024 dated 03.03.2024 and Office Order No. 45 of 2024 dated 11.03.2024 regarding Annual General Transfer for the 'Transfer Year – 2024' in the cadre of Social Security Officer/ Manager-Grade-II/ Superintendent *vide* which grievances through the Transfer Grievance and Redressal Module under existing HRMS module, were called from the concerned officers with regard to their transfer/posting in the aforesaid orders.

Competent Authority, on the recommendations of 'Transfer Grievance Redressal Committee', considered and disposed of the online grievances received from the officers in the above cadre. Decision thereof is being communicated to the concerned officer through the employees' HRMS portal as per the provisions of transfer policy. Accordingly, following is ordered:

- (A) The officers mentioned at SI. No. 21, 54, 140, 588 & 718 of Office Order No. 35 of 2024 dated 03.03.2024 and SI. No. 61, 65, 98 & 227 of Office Order No. 45 of 2024 dated 11.03.2024 have been retained at their present place of posting.
- (B) The officers mentioned at SI. No. 237, 373, 598, 637 & 682 of Office Order No. 35 of 2024 dated 03.03.2024 have been retained at their present station. However, concerned Regional Directors are directed to transfer these officers at another office within station under intimation to this office.

- (E) The officers mentioned at SI. No. 25, 38, 51, 53, 56, 118, 130, 167, 193, 205, 279, 320, 341, 350, 358, 387, 414, 483, 500, 547, 557, 562, 626, 661, 677, 714 & 734 of **Office Order no. 35 of 2024 dated 03.03.2024** and SI. No. 7, 10, 20, 26, 53, 59, 62, 64, 66, 69, 72, 81, 114, 149, 190, 193 & 230 of **Office Order No. 45 of 2024 dated 11.03.2024** have been allowed for retention up to **31.03.2025** at their present place of posting on the ground of their children appearing in X^{th}/XII^{th} for

the academic session 2024-25 subject to proper verification of relevant documents by concerned Head of Office/ Controlling Officer. After such verification, if found bona fide, they shall, accordingly, be relieved by respective Head of Office / Controlling Officers on 31.03.2025 (A/N) or till the end of session whichever is later, with the directions to report at their ordered place of posting in terms of referred transfer orders.

In addition to above, any other eligible case falling under aforesaid category of children appearing in X^{th}/XII^{th} for the academic session 2024-25 may be retained at their present place of posting in terms of clause (c) of Office Order No. 35 of 2024 dated 03.03.2024 and Office Order No. 45 of 2024 dated 11.03.2024 under intimation to this office.

(F) Relieving of officers mentioned at SI. No. 224, 308, 361, 399, 465, 643, 664 & 680 of Office Order No. 35 of 2024 dated 03.03.2024 and SI. No. 63, 94, 149 & 234 of Office Order No. 45 of 2024 dated 11.03.2024, is kept on hold for the time being till further orders.

All officers transferred under Office Order No. 35 of 2024 dated 03.03.2024 and Office Order No. 45 of 2024 dated 11.03.2024, except the officers detailed in para (A), (B), (C), (D), (E) & (F) above, shall *stand* relieved from their present place of posting *w.e.f.* 23.09.2024 (A/N), if not relieved earlier, by their Controlling Officers/ Head of Office with the direction to report at their ordered place of posting in terms of aforesaid Office Orders.

Relieving/ joining report shall, accordingly, be sent to all concerned by the respective Head of Office/ Controlling Officers with a copy to estt1-hq@esic.nic.in.
